

There have been some widespread rumours that the BUAV would be withdrawing their services as umpires for this weekend's division 1 games. I am pleased to say this situation will not occur and the BUAV have made their services available and will be rostered onto games as usual.

While there is truth to the rumour that the BUAV would take this action, I can confirm that the relationship between BV and the BUAV remains one of collaboration, resulting in an amicable outcome and the avoidance of this unfortunate circumstance.

The subject of umpire abuse from spectators, players and club personnel continues to be an issue we are working through. It has also been the main grievance of the BUAV members during this recent period. I made reference to this last week and I will revisit this topic again today.

As members of Baseball Victoria and leaders in your club, you are obligated under our member protection policy (MPP), to provide a safe and inclusive environment for participation, in the context of the roles you play within your community. BV requires you to meet this obligation with every intention to uphold as outlined in the MPP.

We are investigating a number of accusations made against clubs who are said to be encouraging an environment that is both antisocial and abusive towards umpires. We will not tolerate or support this occurrence within our membership and we intend to complete a thorough investigation to address this issue.
